GIFTS THAT GIVE BACK

With Endow Iowa, donations to community foundations cost donors less. For example, a \$10,000 gift could cost just \$4,725.

Gift: \$10,000
Endow Iowa Tax Credit (25%): (\$2,500)
Net Federal Deductible Gift: \$7,500
Federal Tax Savings (37%): (\$2,775)
Net Cost of Gift: \$4,725

3 STEPS TO RECEIVE YOUR ENDOW IOWA TAX CREDITS

1. After your contribution is received, the Community Foundation will send you the Endow Iowa tax credit application form. You must complete the form and return it to the Community Foundation for processing.
2. The Community Foundation will complete the application and send it to the Iowa Economic Development Authority, who administers the Endow Iowa Tax Credit Program.
3. The Iowa Economic Development Authority will send you a letter when your tax credits have been awarded. Your award letter will contain a code used to apply your credits when your taxes are prepared.

HOW IT WORKS

- A variety of gifts qualify for Endow Iowa tax credits including cash, real estate, appreciated securities and outright gifts of retirement assets.
- Gifts can be made to the Greater Cedar Rapids Community Foundation to an existing endowed fund or one that you establish any time throughout the year. The gift(s) must benefit one or more Iowa charitable causes.
- Tax credits equal to 25 percent of the value of the gift are limited to \$100,000 per individual or \$200,000 per couple if both are Iowa taxpayers.
- Eligible gifts will qualify for credits on a first-come/first-serve basis until the yearly appropriated limit is reached. If the current available Endow Iowa tax credits have been awarded, qualified donors can apply for Endow Iowa tax credits the following year as long as it is submitted within 12 months of the date of the gift. The Community Foundation encourages donors to act early in the year to ensure they receive Endow Iowa tax credits.
- All qualified donors can carry forward tax credits for up to five years after the credits are awarded.
- Endow Iowa tax credits allow donors to have even greater philanthropic impact.
- We encourage donors to consult with their tax advisor to review their individual circumstances.
