

COMPETITIVE GRANT PROGRAMS

For Organizations Under Seven Years Old

Check each grant opportunity on our website for full eligibility criteria including organization type, age, budget, and location.

PROGRAM SUPPORT GRANTS

Program Support Grants support programs or projects of nonprofits serving Linn County, Iowa.

- Organizations may apply for a Program Support Grant and/or an Organization Support Grant in the Spring or Fall grant cycle if they do not have a currently active grant in the program for which they are applying.
- Organizations may apply for a two-year Program Support Grant and/or an Organization Support Grant with the following exceptions:
 - Program Support requests for new projects or programs are limited to a single-year request.
 - Organization Support requests from organizations less than two years old (based on date of IRS determination letter) or organizations using the Organization Support short application option are limited to a single-year request.
- For organizations with operating budgets greater than \$150,000, the maximum request amount is \$30,000 per year.
- Organizations with operating budgets less than \$150,000 may request an amount up to 20% of their operating budget per request (rounded up to the nearest \$100).
 - The Community Foundation generally does not fund more than 20% of an organization's operating budget between Program Support and Organization Support grants total in a calendar year.
 - Organizations that are primarily volunteer-driven and/or have a very small operating budget should contact the Program Officer to discuss the eligible amount for their specific situation.

LINN COUNTY GRANTS

Support for efforts in Linn County outside the metropolitan area (Cedar Rapids, Marion, Hiawatha, Robins, Fairfax)

- Organizations can submit one application per year
- Grant Term: 12 months
- Grant Amount: maximum of \$15,000

ORGANIZATION SUPPORT GRANTS

Organization Support Grants provide general operating support for nonprofits based in Linn County, Iowa.

RAPID RESPONSE GRANTS

Support for time-sensitive emergency expenses and emerging opportunities that could not have been submitted within a regular grant cycle.

- Organizations are limited to one grant per 12 months
- Grant Term: Up to 12 months
- Grant Amount: maximum of \$3,000

COMPETITIVE GRANT PROGRAMS

For Organizations More Than Seven Years Old

Check each grant opportunity on our website for full eligibility criteria including organization type, age, budget, and location.

Organizations more than seven years old may be eligible to apply for all grant opportunities outlined on the preceding page (Program Support, Organization Support, Linn County, and Rapid Response). In addition, organizations more than seven years old may be eligible to apply for an Endowment Challenge grant as outlined below.

ENDOWMENT CHALLENGE GRANTS

Endowment Challenge Grants are matching grants supporting nonprofit organizations in building endowments in Linn County, Iowa. The matching endowment fund is opened and held at the Greater Cedar Rapids Community Foundation. Nonprofit endowment funds invest in the mission and the future of the organization by providing general operating support, stability during cyclical income variances, and income for areas of high importance to the organization.

- Grant of \$25,000, awarded as a 1:3 matching grant
- Five years to meet the match

Nonprofit organizations that are at least seven years old (based on the date of the IRS letter of determination) and hold 501(c)(3) status may apply if they meet two or more of the following criteria:

- The organization is based in Linn County, Iowa
- The organization serves residents of Linn County, Iowa
- An awarded Endowment Challenge Grant will only serve residents of Linn County, Iowa
- The organization currently holds one or more nonprofit endowed funds at the Community Foundation. The fund(s) must have been opened AND have a balance at or above the \$10,000 fund minimum at least one year prior to the date of application.

The Community Foundation administers competitive grants for local corporations and family foundations. Competitive Donor-Advised Funds are donor-driven. The funding priorities, exclusions, decision-making, and timing of grant awards are determined by the donor.
